## **Budget summary**

Health and social care budget summary:

- £2bn a year extra for mental health by 2023/24 with "crisis cafes", specially-equipped ambulances, devoted school teams and guaranteed A&E support
- All future PFI deals will be banned stopping hospitals from taking on huge new building debts.
- £10m will be made available to air ambulances to help them keep flying
- £650m extra social care funding for English councils for 2019/20
- Disabled Facilities Grant gets another £45m in 2018/19
- Children's social care programmes get another £84m over five years to expand programmes to 20 further councils.

# Department of health and social care: Technical notice on recognition of professional qualifications

The latest batch of technical notices outlining the government's preparations for a no deal Brexit scenario was released on Friday 12 October. It included guidance on providing services as a qualified professional. The notice states that, in the event of no deal, the Mutual Recognition of Professional Qualifications (MRPQ) Directive will no longer apply to the UK.

# King's Fund: Sustainability and transformation partnerships in London: an independent review

# House of Commons Health and Social Care Committee: Antimicrobial resistance This report states that tackling antimicrobial resistance needs to be established as a 'top five policy priority' for the government in order to help prevent the virtual loss of worldwide modern medicine. No new classes of antibiotics have been developed for decades. Investment in basic scientific research is essential but so too is the investment by pharmaceutical companies in further development and bringing products to the market.

# WHO: Will population ageing spell the end of the welfare state? A review of evidence and policy options

This brief reviews the main evidence on the health and long-term care costs associated with ageing populations to better understand the expected cost pressures due to changing demographics. At the same time, it explores how older populations can and do contribute meaningfully both in economic and societal terms, particularly if they are able to remain healthy and active into later life. It concludes by reviewing selected policy areas that have been shown to either support the health and activity of older people or which otherwise reinforce sustainable care systems more broadly in the context of population ageing.
